

Your household has been selected for Statistics Finland's Household **Budget Survey!**

The Household Budget Survey produces data on changes in households' consumption and use of money, as well as on differences in consumption between various population groups. This information can be obtained only by inquiring from households. We ask about your household's housing costs, purchases of goods and use of services, for example.

Statistics Finland is a government statistical agency, which produces statistics and conducts surveys describing conditions in society. Statistics on households' consumption are compiled from the data obtained in the survey.

Participation is important – this is how it is done

Statistics Finland's interviewer will call you in the near future to agree on a convenient time for the interview.

- The data collection has two stages. It includes an inquiry section (possible to be made partly • online) and collection of the household's purchase receipts for two weeks.

You are irreplaceable as a respondent

Up-to-date information is needed because the previous data on consumption are from 2016. Altogether 8,000 households in Finland have been selected to the inquiry at random. Your household is one of the households selected to the survey. We appreciate your and your household's participation.

In the course of 2022, all survey participants will enter a prize draw every two weeks to win a gift voucher of EUR 500.

We ensure that your data are protected

We handle your responses in a confidential manner. Statistics Finland's employees are obliged to secrecy. We use the data you have given for compiling statistics on households' consumption. The Household Budget Survey is utilised as the data source for social welfare studies and for planning social and economic policies.

It is not possible to identify the households or persons having participated in the survey from the statistical data. Statistical data can be released for statistical surveys and scientific research. Data to be combined with the collected data	To make responding easier and enable versatile research use of statistical data, the collected data can be supplemented with register data from different periods of time. The following data can be combined to the collected data: the respondents' and their household-dwelling unit members' year of birth, registered gender, marital status, family, residence and place of residence data, education and qualification data, income, benefit and employment data, occupation and workplace data, job search data, debt, tax and wealth data, mother tongue, nationality and country of birth, health and health care data. No names or personal identity codes are shown in the survey data. Unfinished answers can also be utilised in the data.
