What is the purpose of this update?

This document tells you how the Australasian Managed Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Australasian Managed Fund aims to provide a higher return over the long term. It invests in an actively managed portfolio of growth assets located predominately in New Zealand and Australia with a very minor allocation of income assets. Volatility is likely to be high. Returns will vary and may be low or negative at times.

What are the risks of investing?

Example of how this applies to an investor

Hannah had \$10,000 in the fund at the start of the year and did not make any further contributions, and the fund generated the same gain as the market benchmark (adjusted for expected fees). At the end of the year, Hannah received a return after fund charges were deducted of \$197 (that is 1.97% of her initial \$10,000).


