## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoter, participating Coles supermarkets and agencies associated with this promotion are ineligible to enter. - 7. To enter the promotion, individuals must then undertake the following steps during the Promotional Period:

  - Input the requested details including their full name, mobile phone number, a valid email address and residential address;
  - Input their Flybuys membership number (if they are a FlyBuys member):
