


FACTOR 1: THE REVALUATION

- Stellar Network Bringing banking to the unbanked worldwide. Developed to help ALL of humanity! Linked to the RV. Military OP.




Basel III

- A worldwide standard that enhance the international banking regulatory framework, greatly improving risk management and promoting transparency
- Gold moving from Tier 3 Asset to Tier 1, which allows physical gold in bullion form to be counted at 100% value for reserve purposes
- Because of the financial collapse from 2007-2009, Basel III was introduced
- International regulatory framework for banks
- Deadline at the 28th June 2021
- The requirement that banks must maintain a minimum capital amount of 7% in reserve
- Require banks to hold unencumbered physical gold valued at 100%
- This will make banks less profitable, because they can no longer earn money on the interest rate

Bretton Woods 3

The Bretton Wood 1 agreement was set in 1944, when the USD was set as the world reserve currency, where you could hold US Dollar and convert them into physical gold with a ratio of 35\$ for 1 ounce of Gold. In 1971 Nixon stopped the convertibility of dollars into Gold, and took the monetary system off the Gold Standard introducing the FIAT system, moving in to BW2.


- BW3 = A move back from FIAT to commodity based monetary system where currencies needs to be backed
- With BW3 The US Dollar is no longer being set as the world reserve currency
- According to Credit Suisse BW3 started in march 2022 when sanctions and freezing of their USD reserves started to rain on Russia for invading Ukraine






ISO 20022 STANDARD

- An international standard for relaying electronic messages between financial institutions
- Created to give the financial industry a common platform for sending payments messages and exchanging payments data
- Banks and financial institutions globally are set to transition their payment systems from using SWIFT to the new, highly structured and data-rich ISO 20022 standard.
- Better quality and faster payments for everyone involved in the payments chain
- An open standard used by anyone in the industry of financial services and implemented on any network
- Instant payments















- Power and policy from we the people



- In the end, everyone in the world must come into QFS through Stellar. No way around it!









Why BTC and ETH death


THE BLACK SWAN EVENT





- The initiative was officially launched by Chinese President Xi Jinping on a state visit to Indonesia in October 2013


