**INTRODUCTIONS:**

Mr. Brian Madison called the meeting to order at 3:05 p.m. and board members Ms. Katherin Chi and Mr. Barato Britt were announced.

**2022-C10-033****Certification: Trash Liens**

Under Chapter 361 of the Revised Code of the Consolidated City of Indianapolis and Marion County the Department of Business and Neighborhood Services (“DBNS”) is responsible for the inspection, abatement, and enforcement of environmental public nuisances. In the event that the property owner does not correct the violation or cannot be found, the City enlists a contractor to abate that property. Section 361-107 of the Revised Code authorizes DBNS to abate the violation and charge the costs related to abatement to the responsible property owner.

Section 361-107(b)(3) of the Revised Code provides that in the event these abatement costs are unpaid, the City shall place a lien upon the property.

Financial Information:                    There are a total of 99 trash cases with a total amount owed of \$51,911.26. The cases reflect outstanding fees 30 days past due as of October 27, 2022.

Funding Source:                         N/A

Mr. Sam Khosrawi, Financial Analyst, reviewed the October Trash Lien Presentation with the Board. The average case amount was \$524.36, and the highest lien case was VIO22-005155 located at 235 Hancock Street. This is a residential property owned by an individual. The abatement consisted of 10 hours of labor and 5 hours of bobcat service to abate 5.2 tons of trash. The highest three zip code areas for this abatement cycle were 46201, 46222, and 46218.

The year-to-date comparison of October 2022 to October 2021 lien cases showed a reduction of 80 trash cases in 2022, resulting in a decrease of \$23,990.00.

MOTION: Mr. Britt moved to adopt Resolution 2022-C10-033. Seconded by Ms. Chi. Motion carried.

**2022-C10-034****Certification: High Weeds and Grass Liens**

Under Chapter 575 of the Revised Code of the Consolidated City of Indianapolis and Marion County the Department of Business and Neighborhood Services (“DBNS”) is responsible for the inspection, abatement, and enforcement of environmental public nuisances. In the event that the property owner does not correct the violation or cannot be found, the City enlists a contractor to mow and/or clean that property. Section 575-7(a) of the Revised Code authorizes DBNS to abate the violation and charge the costs related to abatement to the responsible property owner.



Section 575-7(3)(b) of the Revised Code provides that in the event these abatement costs are unpaid, the City shall place a lien upon the property.

Financial Information: There are a total of 247 mowing cases with a total amount owed of \$125,533.00. The cases reflect outstanding fees 30 days past due as of October 27, 2022.

Funding Source: N/A

Mr. Sam Khosrawi, Financial Analyst, discussed the High Weeds and Grass portion of the lien presentation with the board. The average lien case amount was \$508.23. The highest lien amount for this certification cycle was for HWG22-00087 located at 711 East 38th Street. The property is a 1.3-acre commercial retail structure that was mowed four times during this cycle. The three highest zip code areas for this cycle were 46208, 46222, and 46218.

The year-to-date comparison of September 2022 to September 2021 High Weeds and Grass lien cases showed a reduction of 261 cases in 2022, resulting in a decrease of \$195,218.00.

Mr. Britt asked Mr. Khosrawi if it would be possible to obtain something showing the areas with higher concentrations of lien case amounts. Mr. Madison shared that the department could provide something with GIS visualization for Mr. Britt. Mr. Madison explained that the GIS mapping for this information is best viewed when looking at a full years' time. There are many ways to break down the information Mr. Britt was requesting. Ms. Heikes shared that the lien data has historically been used while comparing similar programs like the High Weeds and Grass and vacant boarding programs. There tends to be clear overlapping of areas with vacant housing and abatement properties. The last map showing this overlapping data for 2021 was generated about eight months ago. An updated map can be generated and provided. Ms. Heikes clarified that the map has historically depicted the areas with the highest case amounts rather than the areas with the largest lien amounts. Mr. Britt stated that a map showing the larger concentration of lien case numbers would be fine. Mr. Madison pointed out that the maps could focus on just the Martindale Brightwood area, or they can show the entire county. Mr. Madison assured Mr. Britt they could discuss mapping and provide him with more data after the meeting.

MOTION: Mr. Britt moved to adopt Resolution 2022-C10-034. Seconded by Ms. Chi. Motion carried.

**2022-C10-035                      Contract: Spay/Neuter Services**

Allows the Director of the Department of Business and Neighborhood Services to amend the existing agreement with the IndyHumane Downtown Clinic to provide spay/neuter services for animals in the care of the IACS shelter.



Financial Information: \$200,000.00 increase

Funding Source: City-County General Fund

Mr. Jacob Miller, Chief Project Coordinator—Financial Operations, informed the Board that DBNS and the Animal Care Service division wish to amend the existing two-year professional services agreement with the IndyHumane Downtown Clinic. The ACS shelter and staff require the contracted services of qualified animal clinics and medical treatment facilities to carry out its duties and responsibilities to the animals of Marion County in the care of ACS. DBNS and ACS staff find IndyHumane Downtown Clinic to be qualified to provide these necessary professional services and thus awarded a two-year agreement that remains valid through December 31, 2023. The compensation not-to-exceed limit was originally established at \$134,000.00. Due to shifting schedules and capacities among the ACS spay/neuter clinic vendor pool, it is now apparent that the IndyHumane Downtown Clinic contract compensation limit must be increased to adequately fund the remaining term of the agreement. The volume of work assigned to the other contract claims in the vendor pool decreased accordingly to offset the increase to IndyHumane Downtown Clinic. The compensation not to exceed limit shall be increased by \$200,000.00 for a new not-to-exceed limit of \$334,000.00. The rates of the agreement shall not be increased with this amendment. The term of the agreement will expire December 31, 2023.

Ms. Trennepohl shared that ACS has been using IndyHumane’s services the entire six years she has been with the shelter. They are one of the shelter’s best partners and they can handle more volume than any of the other clinics. Other clinics have had to cut back surgeries, so ACS has spent more money with IndyHumane Downtown Clinic. Mr. Madison reminded the Board that the spay/neuter services are extremely important for the animals in the shelter to be adopted and leave the shelter.

MOTION: Ms. Chi moved to adopt Resolution 2022-C10-035. Seconded by Mr. Britt. Motion carried.

**2022-C10-036                      Contract: Boarding Services**

Allows the Director of the Department of Business and Neighborhood Services to renew the services agreement with C.P. Total Construction, LLC for one (1) additional year.

Financial Information: \$325,000.00  
(No increase to rates or total compensation)

Funding Source: Permits Fund

Mr. Jacob Miller, Chief Project Coordinator—Financial Operations, informed the Board that DBNS was requesting authorization to renew the existing services agreement with C.P. Total Construction, LLC for boarding services. DBNS is charged with the responsibility of securing



vacant, unsafe, and abandoned structures throughout Marion County. Carrying out this duty, DBNS solicited qualifications from vendors and then awarded a one-year service agreement to C.P. Total Construction, LLC, an Office of Minority and Women Business Development (OMWBD) certified minority-owned business enterprise. C.P. Total Construction, LLC has demonstrated the skills and experience necessary to participate in the City’s Unsafe Building Boarding program. The contract’s compensation not-to-exceed limit was established at \$325,000.00 and the expiration date was set for January 31, 2023. In consideration of the vendor’s success within the program and willingness to renew current pricing, DBNS has now requested approval from the Board to renew the agreement for a second year, which will then expire at the close of business January 31, 2024. The current rates and contract not-to-exceed limit shall not be increased with this amendment.

MOTION: Mr. Britt moved to adopt Resolution 2022-C10-036. Seconded by Ms. Chi. Motion carried.

**2022-C10-037                      Contract: Organizational Analysis and Consulting**

Allows the Director of the Department of Business and Neighborhood Services to enter into a new consulting agreement with Resultant, LLC to provide to BNS formal recommendations and in-depth analysis of key organizational structures, roles, processes, and systems.

Financial Information:                      \$48,985.00

Funding Source:                              Permits Fund

Mr. Jacob Miller, Chief Project Coordinator—Financial Operations, informed the Board that DBNS was requesting authorization to enter into a new professional services agreement with Resultant, LLC for professional organizational analysis and consulting services. Resultant, LLC will collaborate with staff and leadership in the first phase to understand the current organization of DBNS, its various stake holders, and departmental operations. Following the completion of phase one, Resultant, LLC will evaluate DBNS and ultimately develop and provide recommendations to the department. With DBNS Board approval, the department will finalize this new contract and it shall commence immediately and expire close of business on February 28, 2023. The compensation not-to-exceed limit shall be established at \$48,7895.00.

Mr. Britt asked if Mr. Madison could provide a general background for Resultant, LLC and the services they provide for DBNS. Mr. Madison shared that Resultant, LLC was formerly known as KSM Consulting, whom DBNS had previously utilized to look at a small section of the department’s services. The contract with KSM Consulting was approved four or five years ago. This contract will take a wholistic look at the department and allow the department to see how we operate and strategize for how we should move forward in terms of processes, technology, and organizational structure. The desired result is for recommendations regarding needed resources and investments throughout the department. It will be a comprehensive study



performed by a third party. The Department of Metropolitan Development (DMD) has recently utilized Resultant, LLC's services and may still be under contract with them.

Ms. Chi asked for clarification that there may be additional phases added based on Resultant, LLC's recommendations. Mr. Madison confirmed that there could be a second phase that would also be brought to the Board for approval. The first phase will be a very high-level analysis and initial conversations at the leadership and external levels. DBNS works and interacts with many different agencies such as Public Works (DPW), the Department of Metropolitan Development (DMD), the Health Department, and various other departments.

Ms. Chi pointed out that the contract will start immediately and end February 28, 2023. Mr. Madison stated that the first phase would be quickly carried out. Mr. Miller added that the first phase was projected to be a two-month process, but extra time was added with the upcoming holidays.

MOTION: Ms. Chi moved to adopt Resolution 2022-C10-037. Seconded by Mr. Britt. Motion carried.

**2022-C10-038                      Contract: Insight Public Sector, Inc.**

Allows the Director of the Department of Business and Neighborhood Services to enter into a new Agreement with Insight Public Sector, Inc. for various Flock Group Inc. technology products, related equipment, and services.

Financial Information:                      \$17,100.00 increase

Funding Source:                              Permits Fund

Mr. Jacob Miller, Chief Project Coordinator—Financial Operations, informed the Board that DBNS requests approval to contract with Insight Public Sector, Inc. to purchase, use, and have installed access to Flock services, a technology platform that offers a software and hardware solution for automatic license plate detection that can produce images and recordings of vehicles caught or suspected of illegal dumping. It will then send notifications to the contracting agency, DBNS. Illegal dumping in Indianapolis – Marion County contributes to plight in community health and quality of life. As the practice of illegal dumping continues, the City and DBNS must continue to push back against the violators, passing on their hauling and disposal costs to property owners and taxpayers. The City and DBNS are now seeking new tools and methodologies to discourage and enforce against the harmful activity. Insight Public Sector, Inc. will provide DBNS with Flock service license plate reader technology, giving DBNS a new set of tools to dispatch to the City's areas of highest impact. Flocked Services is available to the City via the city-approved OMNIA Partners Cooperative Purchasing Organization Contract Number 4400006644. The DBNS cover agreement compensation shall not exceed an initial limit established at \$17,100.00.

Ms. Heikes shared that the contract was for six cameras and that she was excited to see how the new technology was going to work with our processes. Long-term, if the technology works well, the Board can expect to another request to expand on the current contract.

Mr. Madison mentioned that the department has previously used solar powered cameras that can be relocated. Technology has changed since the previous cameras were acquired and this contract looks to have technology that will allow the department to do more and aligns with our illegal dumping needs.

Ms. Chi asked if the cameras were installed at specific sites or in cars. Ms. Heikes stated that the cameras are not in cars and that they typically are installed on AES Indiana's poles in the right-of-way. The cameras are often monitoring alleys or vacant properties. The locations are based on the volume of complaints for repetitive dumping that come in for certain areas. These cameras will be similarly placed. However, they have more installation flexibility. These cameras have their own pole system they can be installed with rather than just being installed on AES Indiana's poles. Multiple cameras can be installed to cover multiple angles as well. The current limitations with the three cameras the department owns is that they are cumbersome to install and must be installed in locations where there is only one way in and out to ensure we get an image of the license plate. Mr. Madison added that this camera system will allow the department to access video and information from anywhere. With the current camera system, DBNS must physically go to where the camera is located to download information through Wi-Fi or Bluetooth technology.

MOTION: Mr. Britt moved to adopt Resolution 2022-C10-038. Seconded by Ms. Chi. Motion carried.

WHEREAS, the Department of Business and Neighborhood Services (hereinafter "DBNS") is authorized to inspect and abate environmental public nuisances by Chapter 361 of the Revised Code of the Consolidated City of Indianapolis and Marion County (the "Revised Code"); and

WHEREAS, DBNS has abated environmental public nuisances on the properties listed on Attachment A as provided in Chapter 361 of the Revised Code; and

WHEREAS, Section 361-107 of the Revised Code provides that a property owner shall pay to DBNS certain fees and charges which DBNS incurs in removing environmental public nuisances; and

WHEREAS, Section 361-107(b)(3) of the Revised Code provides that in the event that the abatement costs incurred by the City are unpaid, the City shall have a lien upon the property in question for those unpaid costs; and

WHEREAS, DBNS has provided adequate notice and billing, by first class, United States mail, postage prepaid, to the property owner of record as listed in the assessor's office; and

WHEREAS, the property owner has either failed to respond to this notice and/or bill, or the notice and/or bill has been returned as undeliverable; and

WHEREAS, after diligent research by DBNS, it has been unable to locate those owners whose notice and/or bill was returned as undeliverable; and

WHEREAS, a lien should be placed against the properties listed on the attached Exhibit A in the total amounts as shown.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Business and Neighborhood Services approves Resolution # 2022-C10-039, approves the list of properties attached as Exhibit A, and authorizes the Department of Business and Neighborhood Services to undertake any and all actions as required by Indiana Code Section 36-1-6-2 and 36-3-7-5 and Chapter 361 of the Revised Code, to ensure that the liens are perfected and placed against the listed properties, and collected pursuant to the statutory procedures for the collection of special assessments. Such authorization may include, but is not limited to, the filing of the list with the Marion County Treasurer's Office.

WHEREAS, a lien should be placed against the properties listed on the attached Exhibit A in the total amounts as shown.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Business and Neighborhood Services approves Resolution #2022-C10-040, approves the list of properties attached as Exhibit A, and authorizes the Department of Business and Neighborhood Services to undertake any and all actions as required by Indiana Code Section 36-1-6-2 and 36-3-7-5 and Chapter 575 of the Revised Code, to ensure that the liens are perfected and placed against the listed properties, and collected pursuant to the statutory procedures for the collection of special assessments. Such authorization may include, but is not limited to, the filing of the list with the Marion County Treasurer's Office.

WHEREAS, the BNS staff members responsible for carrying out these duties and responsibilities interact and communicate daily with the City's diverse businesses, citizens, property owners and pet owners; and

WHEREAS, to communicate effectively and equitably, BNS requires the services of a contracted vendor to perform language translation and interpretation services; and

WHEREAS, to retain these services, BNS contracted with Indianapolis Interpreters Inc. d/b/a LUNA Language Services for a term of one year, with the agreement due to expire at the close of business December 31, 2022 (12/31/2022); and

WHEREAS, BNS now desires to renew the term of the professional services agreement with Indianapolis Interpreters Inc. d/b/a LUNA Language Services for one additional year of language translation and interpretation services; and

WHEREAS, Chapter 226 of the Revised Code provides that the Board of Business and Neighborhood Services shall approve professional or consulting contracts entered into by BNS; and

NOW THEREFORE BE IT RESOLVED, that the Board of Business and Neighborhood Services hereby authorizes the Director of the Department of Business and Neighborhood Services to renew the 2022 BNS language translation and interpretation professional services agreement with Indianapolis Interpreters Inc. d/b/a LUNA Language Services for one additional year.
