

Acupuncture Clinical Internship Requirements:

Students of the Acupuncture course are eligible for the Certified Veterinary Acupuncturist certification endorsed by Chi University. The CVA certification requirements include a 30-hour clinical internship. The internship requirement can be fulfilled through various methods:

Clinical Internship: Shadow any CVA certified by Chi University or IVAS. One hour shadowing = 1 internship hour. We will not accept hours prior to the start of your acupuncture class; however, we also recommend waiting until after Session 4 to ensure that you have a good idea what you are observing. If you shadow too early, you will not get the full benefit of what you are being shown. You can find a Chi University CVA in your area by consulting our practitioner directory at https://alumni.chiu.edu/. Veterinarians who have completed the Acupuncture course but have not earned their CVA do not qualify as internship supervisors. If you choose to intern with a veterinarian who earned their CVA from IVAS, then they must submit a photo or PDF copy of their CVA certificate to Chi University before any internship hours can be accepted.

When shadowing a CVA, please be mindful of their obligation to their client and patient. Some vets have expressed their reluctance to accept interns after trainees shifted attention from the animal and owner to themselves during sessions. Please do not interfere with the interactions between the client and the CVA and leave questions and comments for the end of the session. Some CVA's may charge you for this internship service.

You may combine hours from more than one CVA; however, each internship supervisor must fill out the internship log (see following page). As a courtesy to your internship supervisor, please hand them the paperwork to sign with the form filled out beforehand. Once complete, you may mail, fax, or scan/email a copy to Chi University for approval. We will send you an email confirmation when your hours are approved.

- 2. Advanced Classes: Earn internship hours through completion of advanced Chi University classes. Only advanced classes begun after starting Session 1 of the acupuncture class will qualify.
 - a. **Online**: Earn a maximum of 15 internship hours (they cannot be combined) by completing one of the following online classes:
 - i. 1 of the 5 Herbal Medicine Modules (Kidney, Liver, Respiratory/Cardiovascular, Gastrointestinal, Dermatology/Oncology) the Chinese Herbal Fundamental Knowledge prerequisite does not qualify!
 - ii. Food Therapy
 - iii. Pain Management
 - iv. Palliative and End-of-Life Care

The following two online classes <u>can</u> be combined with the online classes listed above. For example, completing online Canine Acupuncture Deep Dive AND online Food Therapy will fulfill all 30 required internship hours.

- v. Canine Acupuncture Deep Dive: 15 internship hours
- vi. Equine Acupuncture Deep Dive: 22 internship hours
- b. **On-site**: Completion of an advanced on-site or hybrid class will fulfill all 30 internship hours. Qualifying classes are as follows:
 - i. Advanced TCVM Diagnostics & Acupuncture (Small Animal or Equine)
 - ii. 1 of the 5 Herbal Medicine Modules (Kidney, Liver, Respiratory/Cardiovascular, Gastrointestinal, Dermatology/Oncology) - the Chinese Herbal Fundamental Knowledge prerequisite does not qualify!
 - iii. Food Therapy
 - iv. Tui-na
 - v. Balance Methods Acupuncture
 - vi. Veterinary Topographic Acupuncture
- 3. Annual Conference on TCVM: Attend the Chi University Annual Conference on TCVM to fulfill up to 30 internship hours.
 - a. On-site Lectures: Attend the on-site lectures (one or both lecture tracks) for 15 internship hours.
 - b. Online Lectures: Take the Conference lectures online (one or both tracks) for 7.5 internship hours.
 - c. Workshops: Earn the equivalent number of internship hours as CE hours for each workshop, regardless of whether it's taken online or on-site. For example: attending one 4-hour workshop will accumulate 4 internship hours.
