- Years of living in Finland: if the country of birth is not Finland
- Reason for immigration (annual data)
- Country of birth of the respondent's parents

13. Household data (annual data)

14. Topics to be collected every eight years

- Labour market situation of migrants and their immediate descendants (2021)
- Pensions and labour market participation (2023)
- Young people on the labour market and discontinuation of education (2024)

- Work organisation and working time arrangements (2027)
- Accidents at work and work-related health problems (2028)
