# **ARNOTT'S BISCUITS COLES FEBRUARY PROMOTION 2023**

### TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. The Promoter is Arnott's Biscuits Ltd (ABN 44 008 435 729) of 24 George Street, North Strathfield NSW 2137, telephone (02) 8767 7000 ("**Promoter**").
- 3. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, participating retailers and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
- 4. The promotion commences 12:00am AEDST on 01/02/2023 and ends 11:59pm AEDST on 28/02/2023 ("**Promotional Period**").
- 5. To be eligible to enter individuals must purchase any two (2) participating Arnott's branded products ("**Eligible Product**"), in a single transaction, from any Coles supermarket nationally (including Coles online and/or Coles Express service stations) during the Promotional Period ("**Qualifying Purchase**"). The following Arnott's branded products are not Eligible Products and are exluded for the purposes of this promotion:

- 6. To enter the promotion, individuals must then undertake the following steps during the Promotional Period:
  - Visit <u>http://www.arnottspromotion.com.au;</u>
  - Follow the prompts to the entry page;
  - Input the requested details including their full name, mobile phone number, a valid email address and residential address;
  - Input their Flybuys membership number if they are a FlyBuys member;
  - Upload a copy of their purchase receipt clearly showing where the Qualifying Purchase was made, that two (2) products were purchased (which must both be Eligible Products) and the date of purchase (which must be during the Promotional Period but before submitting an entry); and
  - Submit the fully completed online entry form.
- 7. Once the completed online entry form has been submitted, entrants will receive an online message acknowledging their entry and informing them that (a) they have been awared one (1) initial entry into the major draw ("**Major Draw**"); and (b) if they have won an Instant Prize (as defined below) and if so, details on how to verify their

- 11. The first valid entry drawn will win a \$10,000 Free2Travel credit ("**Major Prize**").

# **Instant Prize**

- 14. There will be:
  - (a) a total of 672 "Hourly Winning Times" during the Promotional Period; and

#### General
