What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The objective of the Conservative Fund is to provide a conservative investment return through investment in a portfolio of actively managed cash, fixed interest, property (including aged care) and infrastructure assets¹, Australasian equities and international equities. The fund has a low to medium level of volatility.

What are the risks of investing?

Risk indicator for the Conservative Fund:



Example of how this applies to an investor


Hannah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hannah received a return after fund charges were deducted of \$1 (that is 0.01% of her initial \$10,000). Hannah also paid \$36 in other charges. This gives Hannah a total loss after tax of -\$35 for the year.


This shows the types of assets that the fund invests in.^{1,3,4,5,6,7}
