Statistics Finland is a government statistical agency, which produces statistics and conducts surveys describing conditions in society.

Grounds for processing personal data

Public interest as intended in the EU's General Data Protection Regulation.

Data to be combined with the collected data

To facilitate answering, the collected data are supplemented with register data. Data to be combined are: education and employment data, as well as demographic variables (e.g. age, sex, marital status, native language and regional data). Family, income, pension, benefit and health data can also be linked to the data for research purposes.

Disclosure of data

Statistics Finland never releases the data received by it to other authorities in a manner that would allow identification of the individuals having participated in the survey.

- Statistics Finland's employees are obliged to secrecy.
- We use the information you have given for compiling statistics that predict economic development.
- It is not possible to identify persons having participated in the survey from the statistical data.
- Statistical data can be released for statistical surveys and scientific research.

Survey results benefit us all

We ask about everyday matters related to the economy, such as your intentions of making small or larger purchases, saving or taking out a loan. Consumers' intentions tell how consumption, saving, taking out a loan and gross domestic product for the whole country will change.

The responses will give an idea of consumer confidence, which is featured regularly on the news.

Data are collected from small pieces

Participation is a civil right. Your responses are utilised when preparing decisions that affect us all. By participating you help to ensure that decision-makers and central government have a view of Finnish society that is based on the right kind of information. All people benefit from this.

From the 1980s onwards, Statistics Finland has asked for consumers' views and expectations concerning their own and Finland's economy. Thousands of persons aged 18 to 74 respond to the survey every year.
