REVISED DOCUMENTATION DEADLINE

The revised documentation deadline is for submission of revisions to originally submitted plans only.

ABSOLUTELY NO NEW SUBMITTALS WILL BE ACCEPTED!!

APPLICANTS MUST MEET WITH AN ARCHITECTURAL REVIEWER AT LEAST FIVE DAYS BEFORE FILING DEADLINE
This is to discuss projects prior to submitting an application. Please keep this in mind when considering timelines and deadlines.
