<b>Promotion:</b>	Apple Gift Card Competition

<b>Eligible entrants:</b>	Entry is only open to Australian residents who are 18 years and over.
<b>How to Enter:</b>	<p>To enter the Promotion, the entrant must complete the following steps during the Promotional Period:</p> <ol style="list-style-type: none"> <li>purchase an Apple Gift Card ("Qualifying Purchase") from any Participating Venue (listed below); and</li> <li>visit <a href="http://www.winbigwithgiftcards.com.au">www.winbigwithgiftcards.com.au</a>, follow the prompts to the Promotion entry page; and fully complete and submit the online entry form with their personal details (first name, last name, email address, mobile number and complete address), enter the Apple gift card's PCN number (located on the back of the activation slip provided), upload a scanned copy or photo of the activation slip of the gift card, and (optional) select the tick box to consent to receipt of marketing from the Promoter.</li> </ol> <p>The scanned copy or photo of the activation slip of the gift card must clearly show the card number, store number and date of purchase. If these details (card number, store number and date of purchase) are not clear on the activation slip, the Promoter reserves the right to invalidate the entry.</p> <p>The entrant must fill out the online entry form for every entry. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry.</p> <p><b>Proof of Purchase:</b> You must keep the receipt for the Qualifying Purchase and the activation slip of the gift card as proof of purchase for all entries ("Proof of Purchase"). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.

The Promoter's privacy policy contains information about how the entrant may access, update and seek correction of the personal information the Promoter holds about them and how the entrant may complain about any potential breach by the Promoter of the Australian Privacy Principles or any other Australian privacy laws and how such complaints will be dealt with. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
18. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. The use of any automated entry software or any
