This Policy explains what personal information we collect from you, either directly or indirectly, and how we use it. Please read this Policy carefully to understand how Galantis (also referred to herein as "we", "us", and "our") may collect, use, and share your personal information.

This Policy does not apply to any data insofar as it is held, processed, disclosed or published in a form which cannot be linked to a living individual (such as anonymized data, aggregated data, or coded data which, in a given form, cannot effectively be used to extract your personal data) ("Anonymized and Aggregated Data"). We reserve the right to generate Anonymized and Aggregated Data extracted out of any databases containing your personal data and to make use of any such Anonymized and Aggregated Data as we see fit.

INFORMATION WE MAY COLLECT

We automatically collect information about you, your use of our website, or information collected by using cookies and similar technologies when you use, access or interact with our website. We may, for example, collect information about the type of device you use to access our websites, the operating system and version, your IP address, your general geographic location as indicated by your IP address, your browser type, the webpages you view on our websites, and whether and how you interact with content available on our websites.

What do we collect about you?

Personal information is any information that can be used to identify a living person or (for certain privacy laws) a household. It does not include data which is anonymised, such that a person can no longer be identified. We collect different information about you when you use this website and the services available on it as follows:

Information provided directly by you to us

If you register to join Galantis's community and/or use any of the services available on the website, including Galantis's community website, you may provide and we may collect details of your name, address, email address, login details, demographic data, blockchain address, phone number, how you use and interact with Galantis's community including feedback and improvement ideas, and your purchase/transactional data (including payment card details) related to Galantis's community.

Information collected through the website or via services

When you visit the website and/or use any of the services available, we will collect the following information about you and your devices: your Internet Protocol "IP" address, Media Access Control "MAC" address. We will in limited situations also collect your geolocation data, for example to verify your attendance at a concert.

For the purposes of certain privacy laws, your geolocation data is regarded as sensitive personal data.

Information Obtained from Other Sources.

We may receive information about you from other sources, including third parties, such as music service partners and partners with whom we offer co-branded services or engage in joint marketing activities. We may also receive information about you from social media platforms. We protect data obtained from third parties according to the practices described in this Policy and we also apply any additional restrictions imposed by the source of data.

For Your Reference, We May Collect the Following Data:

- Forms filled out by you including site registrations (where applicable)
- Subscriptions or orders placed on the Site;
- Participation in discussion boards or other social media functions on the Site;
- Entering competitions, promotions, or surveys;

The customer interactions with Galantis are broken down into the following segments:

Basic User Data.

This includes name, email address, IP address, and information provided by cookies or similar technology to share news about events and products offered by Galantis. The IP address helps us to understand geographic information about our websites' visitors to better improve our website. It is our legitimate interest to process your personal data for these purposes.

Purchasing Data.

We use third party websites to sell Galantis products, including Galantis or Galantis's artist branded merchandise ("Galantis Products"). By clicking the link to the merch store in your region, you acknowledge that you will be subject to such third party's privacy policy and terms of service. By continuing to use such third party site, you acknowledge you have reviewed and agreed to such privacy policy and terms of service. To the extent there is no privacy policy on such third party site, the terms contained herein with respect to our use of any data we receive from such third party site shall apply. You acknowledge that these terms only apply to our use of such data and we make no representations or warranties regarding the use of any data by any third party site.

To effectuate such transactions, we may collect: your name, phone number (optional), email address, delivery/shipping address, and payment information. This information is used solely to complete your transaction, follow up with you about your purchase, help with any delivery issues, handle returns, and other issues related to the purchase of your Galantis Products. We do not store any payment or credit card information. We only use payment information in connection with the purchase of Galantis Products.

We may collect: your name, phone number, email address, location data, your password and IP address. Please note, your password is stored using one-way hash, which means that it cannot be recovered (or disclosed) by anyone, including Galantis.

Why: We collect this information to help get your Galantis services processing correctly. We also use your email to send you Galantis-related notifications, such as promotional messages, information about Galantis Products and/or Services, and to share exciting Galantis news and Product offerings. It is our legitimate interest to process your personal data for these purposes.

Registration Data.

This data includes your email address, location, language preference, Product serial number, IP address, and Galantis account login information (as described above).

Device Identifiers.

When you access or use the Services using a mobile device, we may access, collect, monitor and/or remotely store one or more "device identifiers," such as a universally unique identifier. Device identifiers are small data files or similar data structures stored on or associated with your device that uniquely identify your device. A device identifier may consist of data stored in connection with the device hardware, operating system or other software, or data sent to the device by us. A device identifier may convey information to us about how you browse and use the Services. A device identifier may remain persistently on your device to enhance your navigation on the Services. HOW WE USE PERSONAL INFORMATION

Galantis uses the data we collect to provide you with the Galantis Products and Services we offer, which includes using data to improve and personalize your experiences. We also use the data to communicate with you, for example, informing you about your account, new Galantis Products or Services available, security and other types of updates.

Galantis Uses the Data for The Following Purposes:

- We use data to respond to customer inquiries, diagnose Product problems, and provide other customer care and support services. This processing is necessary to serve our legitimate interest.
- We continually use data for research purposes and to develop and improve our Galantis Products and Services, including maintaining and improving the performance of our Galantis Services, using search queries and clicks to improve the relevance of search results and using usage data to determine what new features to prioritize. This processing is necessary to serve our legitimate interest.
- We use data to protect the security and safety of our Galantis Products and our customers, to detect and
 prevent fraud, to resolve disputes and enforce our agreements. This processing is necessary to serve our
 legitimate interest.
- We use data to develop aggregate analysis and business intelligence that enable us to operate, protect, make
 informed decisions, and report on the performance of our business. This processing is necessary to serve our
 legitimate interest.
- Where you sign up for the Services through an account with a third party content or platform provider, we may
 use data to report to that third party and to communicate with it in relation to your activities on the platform or in
 relation to the content.

We use the data we collect to deliver and personalize our communications with you. For example, we may

- d. Where Galantis has disclosed the information of a European Union user to a third party and the user requests the erasure or rectification of the data, Galantis will take all reasonable steps to inform the third party of such request.
- e. The right to restrict Galantis from processing their information in certain circumstances, such as where the accuracy of that information is disputed or an objection has been raised (see below). In such circumstances, Galantis will only process that information with the express consent of the user, or for the establishment, exercise or defense of legal claims or for the protection of the rights of another natural or legal person or for reasons of important public interest;
- f. The right to receive their information from Galantis in a structured, commonly used and machine-readable format;
- g. The right to object to the processing of their information by Galantis where Galantis has relied on the 'legitimate interest' basis for processing that information (see 'Legal Basis for Data Processing' below), in which case we will immediately stop processing the user's information unless we have compelling legitimate grounds which override

the interests, rights, and freedoms of the user; or the information is used for direct marketing purposes, in which case we will immediately stop processing the user's information for such purposes.

- h. The right to lodge a complaint with the data protection supervisory authority of the EU member state where the user resides. The above legal rights are subject to various conditions and exceptions including where the data is used for statistical or scientific research purposes and the exercise of the right would prevent such purposes from being attained or would seriously impair their attainment.
- i. The above legal rights are subject to various conditions and exceptions including where the data is used for statistical or scientific research purposes and the exercise of the right would prevent such purposes from being attained or would seriously impair their attainment.

Legal Basis for Data Processing.

We process personal data for the purposes set out in this Policy, as described above. Our legal basis to process personal data includes processing that is: necessary for the performance of the contract between you and us (for example, to provide you with the services you request and to identify and authenticate you so you may use the Site); necessary to comply with legal requirements (for example, to comply with applicable accounting rules and to make mandatory disclosures to law enforcement); necessary for our legitimate interests (for example, to manage our relationship with you and to improve the Site); and based on consent by our customers (for example, to communicate with you about our products and services and provide you with marketing information), which may subsequently be withdrawn at any time (by using preference settings in emails or on our Sites, using this form, or emailing us as set out in the Contact section) without affecting the lawfulness of processing based on consent before its withdrawal.

We may use automated decision-making technologies, including profiling, to support our data processing activities. Our automated decision-making capabilities include logic that attempts to identify artists, music, communications, products, or offers that we believe may interest you. By using this logic, it helps us personalize your interactions with Galantis. For you, this means that you may see online advertisements, direct marketing communications (if you have subscribed), or other advertising or marketing messages or special offers based on your activity on our Sites or interactions with Galantis or our third-party partners.

In some instances, you may be required to provide us with personal data for processing as described above, in order for us to be able to provide you to use all the features of the Site.
