**Case Review:**

- **CPCO #2022-042F:** Leslie Johnson, the Complainant, was not present for this case. Mr. Shank presented the case, followed by a review of body-worn camera footage by Director Okello. After discussion, Mr. Shank motioned to endorse the recommended findings. Mr. Riggins seconded the motion. The board vote was unanimous (6-0).
- **CPCO #2022-046F:** Sullivan Nogle, the Complainant, was present for this case and addressed the board. Mr. Riggins presented the case, followed by a review of body-worn camera footage by Director Okello. After discussion, Mr. Riggins motioned to endorse the recommended finding for the allegation against Officer De Leon. Mr. Shank seconded the motion. The board vote was unanimous (6-0). Mr. Riggins then motioned to reverse the recommended finding and sustain the allegation against Officer McBee. Mr. Shearin seconded the motion. The board vote was unanimous (6-0).
