1 Introduction

These instructions describe responding to the Annual inquiry on foreign financial assets and liabilities by means of a CSV file.

By means of the attached file service, you can report in CSV format for the data collection form section 2.2.1 "Equity-based investments to foreign entities where the investees' direct voting power was at least 10 per cent or indirect voting power was over 50 per cent". The file replaces the data already given on the form in the section concerned.

2 Creation of a CSV file

2.1 Start

First give your email address on the Basic information form page. A message will be sent to the email address you gave on whether the sending of the CSV file was successful.

To create a CSV file, you need a CSV template that contains the names of technical variables as column headings. The template can be found in the instructions of the data collection pages for Foreign financial assets and liabilities or by downloading it from the attached file service of the annual inquiry's web form Equity form page in Section 2.2.1. Save the CSV template on your computer in .xls, .xlsx or .csv format.

In addition to the template, you need the code lists for CSV filling, which can be found in the <u>appendix</u> of these instructions or as an Excel table in Statistics Finland's instructions on the data collection pages for Foreign financial assets and liabilities.

2.2 Filling-in the file

Fill in the value fields of the CSV file with financial statement data of foreign investees. Do not make any changes to the column headings of the CSV template. Report the data in millions of euro at the accuracy of two decimal places.

A code is selected for the variables UTC, counterpartCountry, consolidatedAccounts and shareType from the code list of the value in question. If there are more than one investee, enter each investee on separate rows. More detailed descriptions of the technical variables and allowed values, and an example of a filled-in CSV file can be found in Section 3.1 of these instructions.

2.3 Uploading the file to the data collection form

After saving the filled-in CSV file on your computer, upload the file to the data collection form through the attached file service on the Equity form page, Section 2.2.1. Fetch the file you filled in with Browse and send the file with the Send file button, which will transfer the file to Statistics Finland and it will become visible under Sent files in the attached file service.

You get a confirmation message by email in a moment after sending the file. Remember to fill in your contact information in the Basic information tab before uploading the CSV files. The data are transferred to the form in about one minute.

If there is erroneous information in the CSV file columns, you will be notified about this in the email confirmation message. You can correct the CSV file you sent and deliver it again to Statistics Finland. Please note that the CSV file replaces the information already given on the form.

2.4 End

After uploading the CSV file successfully, the investee data are visible in the listing in the annual inquiry's Equity tab in Section 2.2.1.

Please check the data you have given again on the data collection form and mark the data on each foreign investee as completed. The data are marked as completed by ticking Form page completed at the bottom of each investee page and after this by saving the form.

3 Variable descriptions

Technical variables that act as column headings of the CSV file are described in the table below. Code lists on the filled-in variables (country code, data on consolidated subgroup financial statement and form of incorporation) are found attached or alternatively from the Excel table csv_koodilistat.xls, which you can find on Statistics Finland's pages on instructions for data collection. The other values are filled with the investee's financial statement data.

Technical variable (column headings)	Description	Filling-in instructions
respondent	Closest Finnish owner in the chain of ownership, Business ID	Enter the Business ID of the Finnish owner in the chain of ownership closest to the foreign investee.
counterpartEnterprise	Name of foreign investee	Enter the name of the foreign investee.
UTC	Country of location of foreign investee	Select the country code from the code list <u>UTC and</u> <u>counterpartCountry</u> .
counterpartCountry	Country of location of the first foreign investee in the chain of ownership	Select the country code from the code list <u>UTC and</u> <u>counterpartCountry</u> .
LEPCT	Direct ownership percentage of the closest Finnish owner	Enter the direct ownership percentage of the closest Finnish owner in the investee. The ownership share cannot exceed 100 per cent.
LEPCT2	Direct and indirect ownership percentage of the closest Finnish owner in the investee	Enter the sum of the direct and indirect ownership percentage of the closest Finnish owner. Direct and indirect ownership in total cannot be lower than the reported direct ownership. Direct and indirect ownership in total cannot exceed 100 per cent.

consolidatedAccounts	Has the investee prepared a consolidated subgroup financial statement?	Select the code for the consolidated subgroup financial statement from the code list <u>consolidatedAccounts</u> .
shareType	Form of incorporation of investee	Select the code for the form of incorporation from the code list <u>consolidatedAccounts</u> .
balanceSheetTotal	Balance sheet total of investee	Report the balance sheet total of the investee in positive decimals. The data are given in millions of euro at the accuracy of two decimal places.
LE	Equity and appropriations of investee	Report the investee's equity and appropriations in millions of euro at the accuracy of two decimal places.
LE_M	Market value of investee at the end of the reporting year	Enter the investee's market value at the end of the reporting year in millions of euro at the accuracy of two decimal places. The data should be a positive decimal. The data are given only on listed limited companies.
D42A	The investee's profit/loss for the financial period excluding appropriations	Report the investee's profit/loss for the financial period excluding appropriations in millions of euro at the accuracy of two decimal places.
D42B	Extraordinary items included in the investee's result	Give extraordinary items included in the investee's result in millions of euro at the accuracy of two decimal places.
D421A	Dividends and profits distributed by the investee during the financial period	Give dividends and profits distributed by the investee during the financial period in millions of euro at the accuracy of two decimal places. The data should be a positive decimal.
T2	Increases/decreases in equity made during the year	Report the increases/decreases in equity made by the Finnish owner during the year in millions of euro at the accuracy of two decimal places.

3.1 Example

In the example below, the data provider has given financial statements data on three foreign investment targets in Section 2.2.1 of the annual inquiry as a CSV file.

On the first CSV file row, the data provider reports data on a foreign investee Investee 1, whose closest Finnish owner is Business ID 0245491-1. The investee's location country is Sweden (UTC = SE), and in the chain of ownership the location country of the first foreign investee is Sweden (counterpartCountry = SE). The investee has prepared a consolidated subgroup financial statement (consolidatedAccounts = 1) and the investee is an unlisted limited company



(shareType = 2). Data are not given on the investee's market value (LE_M) for unlisted limited companies, for which reason the field in question is empty on row Investee 1. The other data describe the financial statement data of the investee at the accuracy of two decimal places.
