**Proceedings:** President Duane Ingram called the meeting to order at 6:02 p.m.

<u>The Honorable Frank Sullivan</u>: Justice Sullivan gave an overview of the Police Merit Board and their role in the disciplinary process. Deputy Chief Kendale Adams reviewed with the CPCB the changes proposed

by the Merit Board to IMPD's disciplinary procedures and policies. The Merit Board will hold a public hearing on the mater on November 30<sup>th</sup> at 5:30 p.m. in room 2248 where they will entertain comments.

<u>Approval of the September Minutes</u>: Jennifer Norton moved to approve the September minutes. Pastor Bryant seconded the motion. The motion was unanimously approved (7-0).

### **OLD CASES:**

President Ingram moved the old case to the top of the agenda, to be heard before the new cases.

## Case CPCO# 21-013F; Stephen Farris; Detective Stephen Renzulli:

President Ingram and Ashley Gurvitz recused themselves from this case. Without discussion, Jennifer Norton moved to *not* accept the findings of Exonerated on the two allegations and to recommend a finding of sustained. Evan Shearin seconded the motion. The board voted 5 - 0 (with two abstentions) to accept that recommendation. This information will be forwarded to the police chief for further discussion.

### NEW CASE REVIEW:

President Ingram assigned the cases to the members to lead the discussion.

### Case CPCO# 2021-016F; Lawrance Gomes; Officer Smilko, Officer Wogan, Officer Navarro:

Mr. Gomes was present for this case and gave a brief statement as to his view of his case. None of the officers attended this meeting. Julie Barrett presented the case to the board members. After full discussion by the board, Jennifer Norton moved to endorse the recommended findings for the allegations. Michael Bryant seconded the motion. The board voted unanimously to endorse the listed findings.

### Case CPCO# 2021-017F; Edwood Bigot; Officer Zane Faw:

Officer Faw was present for this case but Mr. Bigot was not. Officer Faw presented his version of the events leading up to this complaint. Evan Shearin presented the case to the board members. After full discussion by the board, Mr. Shearin moved to endorse the recommended findings for the allegations. Jennifer Norton seconded the motion. The board voted unanimously to endorse the listed findings.

### Case CPCO# 2021-021F; Carlena Cole; Officer Adriana Gnaster:

Ms Cole did not attend this meeting and Officer Gnaster is no longer employed by IMPD. The board acknowledged the administrative review of the actions of the officer. No vote was needed or taken.

### Case CPCO# 21-028F; Medley Byers; Officer Mitchele Harris, Officer Samuel Steuer:

Ms Byers was present for this case and gave a brief statement reflecting her views of the case. Neither of the officers attended this meeting. Pastor Bryant presented the case to the board. After full discussion by the board, Mr. Shearin moved to endorse the recommended findings for the allegations. Jennifer Norton seconded the motion. The board voted unanimously to endorse the listed findings.
