The following rights have been granted to the personal data owners (referred to as "**Applicant**") defined as Relevant Person in the **The Law on Personal Data Protection No. 6698** (referred to as "**LPDP**") under Article 11 of the LPDP:

- Learning whether your personal data is processed or not
- Requesting information if your personal data has been processed,
- Learning the purpose of processing your personal data and whether they are used in accordance with their purpose,
- Knowing the third parties to whom your personal data are transferred domestically or abroad,
- In the event that your personal data is incomplete or incorrectly processed, requesting that it be corrected and requesting the notification of the transaction made within this scope to third parties to whom your personal data is transferred,
- Although it has been processed in accordance with the provisions of other laws and other legislation regarding LPDP, requesting the erasure or destruction of your personal data and requesting the transaction made within this scope to be notified to third parties to whom your personal data is transferred,
- Objecting to the emergence of a result against you by analyzing the processed data exclusively through automated systems,
- Requesting the removal of damage if you suffer damage due to illegal processing of your personal data.

Pursuant to paragraph 1 of the Article 13 of the LPDP and to the ***Communiqué on the Procedures and Principles of Application to the Data Controller***, the applications to be made to our Company regarding these rights must be sent by e-mail to [kvkk@ph.com.tr](mailto:kvkk@ph.com.tr) or by other methods to be determined by the **Personal Data Protection Board** (Referred to as the "**Board**".) in the future, in writing or by using the e-mail address registered in our Company's system.

- By applying to our company in person by the applicant,
- via Notary public or registered mail,
- If the Applicant has an e-mail address registered in our Company's systems, by sending an e-mail from this address to our Company's [kvkk@ph.com.tr](mailto:kvkk@ph.com.tr) address, with the printout of this form.
