Data disclosure and storage

To facilitate your response, the information you provide will be supplemented with data available from administrative registers. The dataset provided to researchers at the Police University College will include personal information such as gender, age, education, and regional data.

Statistics Finland will transfer the collected data to the Police University College without direct identifiers (name, date of birth, personal identification number, contact information). The Police University College will retain the data until the end of 2026.

After the study is completed, the Police University College will transfer the data it has received to the Finnish Social Science Data Archive, where it will be permanently archived without personal data that would allow direct identification. The data will be used for research, teaching, and study purposes. Statistics Finland stores the data until further notice. The data will be stored in such a way that direct identification of participants from the data is not possible.
