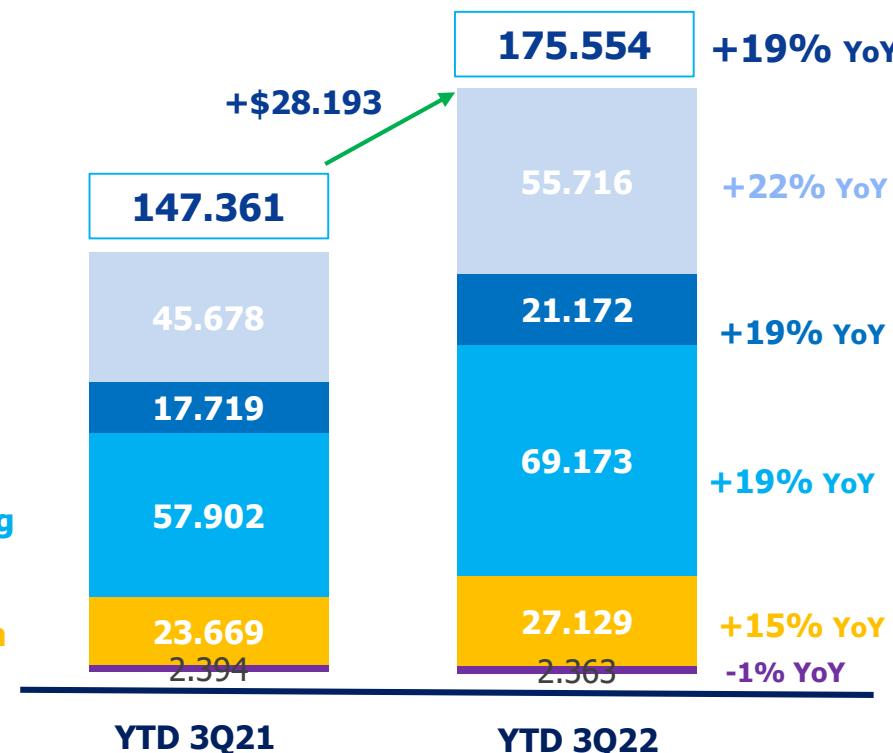

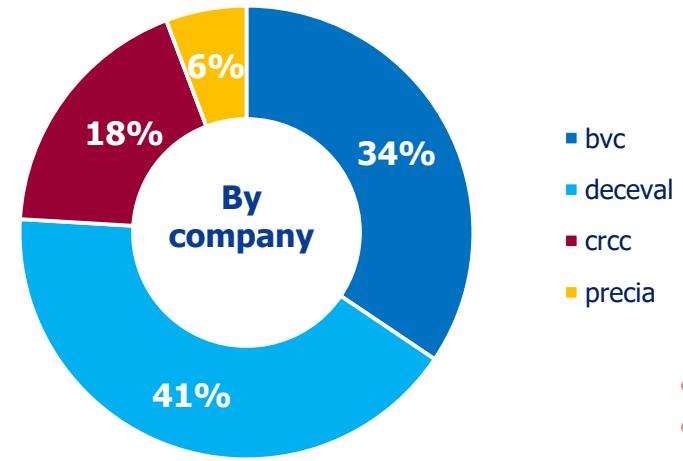
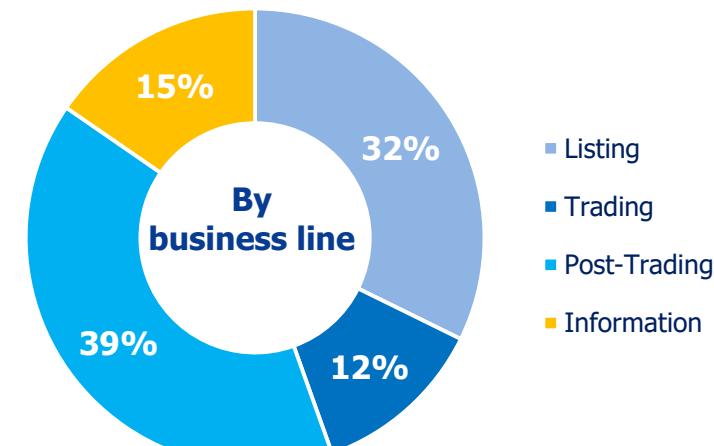
Listing revenues growth resulting from strong performance on YoY basis. Challenging dynamic during the 3Q22 in listing services impacted by lower issuance activity

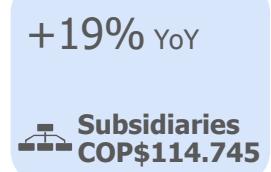

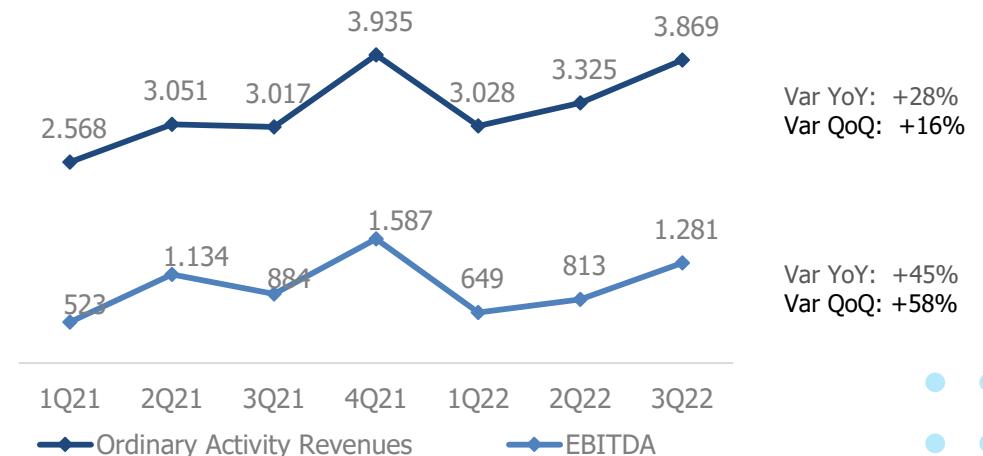
