**Eligible entrants:** Entry is only open to Australian residents who are 18 years or over.

**How to Enter:** To enter the Promotion, the entrant must complete the following steps during the Promotional Period:

- purchase any single Ultimate Gift Card worth \$50 or more ("Qualifying Purchase") from any Big W store (excluding online) within Australia ("Participating Venues"); and
- visit [BigGiftGiveaway.com.au](http://BigGiftGiveaway.com.au), follow the prompts to the Promotion entry page; and fully complete and submit the online entry form with their personal details (first name, last name, date of birth, email address, mobile number, full address and state/territory of residence), enter the Ultimate gift card's PCN number (located on the back of the activation slip provided), upload a scanned copy or photo of the gift card activation slip, and (optional) select the tick box to consent to receipt of marketing from the Promoter.

**Conditions:**

  20. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond

the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.

21. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence).
