What is OWFA?

The Offshore Wind Foundations Alliance (OWFA) is a coalition of six European producers offshore wind turbine foundations: CS Wind Offshore (Denmark), EEW Special Pipe Constructions GmbH (Germany), SIF Netherlands BV (the Netherlands), Smulders Projects (Belgium), Steelwind Nordenham GmbH (Germany) and Haizea Wind Group (Spain).

OWFA members have come together to **advocate for EU policy supporting the ramp-up of offshore wind.** Our aim is to help the EU meet its Green Deal targets, enable a greater uptake of renewable energy, and create more European jobs.

As a coalition we strive to **ensure that manufacturers of offshore foundations take the lead in standards and certification processes** that concern them. We want to make sure that our industry is not overlooked but rather involved in decision-making processes as this contributes to impactful policies.



Lastly, **OWFA is working to establish a level playing field** in the European internal market.
