

**“MICHELIN AUSTRALIA PTY LTD – BICYCLE E-GIFTCARD GIVEAWAY
TERMS AND CONDITIONS**

Eligibility Requirements and the Promotional Period

1. Entry is only open to Australian residents aged 18 years or over (“**Eligible Individuals**”). Excluded Persons are employees of the Promoter and agencies associated with this Promotion (and their immediate families). Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
2. Promotion commences 01st October 2024 and ends 31st October 2024.

Entry Instructions

3. In order to qualify for entry, Eligible Individuals must purchase a set of 2 Michelin bicycle tyres (all patterns included) in a single transaction from a Participating Retailer <https://www.michelin.com.au/bicycle/dealer-locator> and submit their claim through the link provided on-line or at the participating retailer during the promotion period. <https://rewards.michelin.com.au/>
4. There is a strict limit of (1) entry per person.
5. An Eligible Individual having satisfied the criteria set out in Clause 3 will receive a prize (“**Qualified Individual**”).

General

6. Information and terms set out herein on e.g. how to enter and the prizes form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
7. The Promoter reserves the right, at any time, to verify the validity of information supplied pursuant to this Promotion by Eligible Individuals, Qualified Individuals or the Winners (including identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion.
